Glen Arbor Transportation Subcommittee update – Matt Wiesen Matt provided maps illustrating the proposed changes to the business district in Glen Arbor to include bike lanes in addition to vehicle lanes and parking. The cost to the Township will be in the 23,000 – 24,000 range which will also include signage. The work would be complete by Memorial Day weekend. An April 30 deadline is scheduled to include parking and traffic issues and a temporary connector route. If the Township can meet the *Complete Street Resolution* some funding could possibly

be available. The Township Board will review the proposal at the March board meeting.

2. Cheney Road paving – Kent

Money is being budgeted to set aside for the possibility of paving Miller Hill Road.
