Motion to accept the recommended salary increase from the Wage and Salary Advisory Commission for the Clerk's increase by Lewis. Support by Peppler. Roll call vote and motion carried 3 yes and 1 abstained.

Motion to accept the recommended salary increase from the Wage and Salary Advisory Commission for the Treasurer's increase by Peppler. Second by Lewis. Roll call vote and the motion carried 3 yes and 1 abstained.

Motion to accept the recommended salary increase from the Wage and Salary Advisory Commission for the Trustee's increase by Quick. Second by Gretzema. Roll call vote and the motion carried 3 yes and 1 abstained.

Treasurer's Report

Cash on hand as of 02/20/2018 is \$4,094,431.19. Of that amount \$608,000.00 still sits in the tax collection fund and that is yet to be distributed.

The Park Construction Fund has a balance of \$539,000.00.

The Township has accumulated funds in the Debt Service Fund for the Park Bond of \$72,000.00.

General Fund: Expenses: \$10,368.04. Payroll: \$14,928.21. **Motion to approve and pay General Fund expenses and payroll by Lewis. Support by Peppler. Motion carried.**

Emergency Services Advisory Commission Report – Bill Witler – The Commission reviewed the bills and the payroll payments, and recommends payment.

Emergency Services: Expenses \$33,352.91. Payroll: 73,945.64. **Motion to approve and pay the Emergency Services expenses and payroll by Gretzema. Support by Peppler. Motion carried.**

Fire Chief Operations Report – John Dodson – candidate testing – no one was available for testing. Rob Calsbeek and John Dodson have scheduled a meeting with the Union President to discuss recruitment and retention. Budget amendments are being prepared to close out the budget for the year. The Empire building study is complete and was submitted to the board last Tuesday. It is available for review on the Township website. The billing agent will be at the April ESAC meeting to explain the lock box process. The 2% grant from the Grand Traverse Tribe was received. The amount was \$9,824.29. The money will be used for a rescue tool. It is a battery operated jaws of life.
