Township Supervisor, Peter Van Nort, called the meeting to order at 7:30 PM in the Glen Arbor Town Hall meeting room. All members were present. The Pledge of Allegiance was recited.

The agenda was presented. Motion to approve the agenda by Peppler. Support by Gretzema. Motion carried.

Pinning of the new Lieutenant - Chad Dykgraaf. Chad was sworn in by Township Clerk Quick.

Public Comment

Bill Meserve – Dunns Farm Road – representing the Glen Lake Association. The M-22 challenge had approximately 900 participants. Also the GLA staff had a boat wash the night before. There were approximately 360 boats. Mostly kayaks and paddleboards. There have been reports of outbreaks of swimmers itch. There have been 97 Mergansers and chicks removed off the lake. This may mean there is less swimmers itch next year. They were relocated to the bay. The GLA is spending approximately \$100,000.00 this year on swimmers itch. Governor Snyder just signed the bill which includes the second \$250,000.00 budget to control swimmers itch. The GLA hopes to get a large portion of the money to help pay for ongoing expenses.

Treasurer's Report

Cash on hand as of 6/30/2017 is \$2,656, 735.60. Note in the Emergency Services Debt account. There was an error where a check was written out of the Debt Services account for the fire truck payment. It should have been written out of the Emergency Services account. The account was reimbursed from the Emergency Services account. The account last month showed \$9,000.00 and it is now back up to \$90,000.00.

General Fund: Expenses: \$52,161.68. Payroll: \$23,483.01. Motion to approve and pay General Fund expenses and payroll by Gretzema. Support by Lewis. Motion carried.

Emergency Services: Expenses: \$34,248.56. Payroll: \$77,002.26. Motion to approve and pay Emergency Services expenses and payroll by Van Nort. Support by Peppler. Motion Carried.

Emergency Services Advisory Commission Report presented by Roy Pentilla. Because 911 occurs on a Monday, the ESAC meeting is being moved to noon on that day. On July 29^{th} , the Glen Lake Department is having an open house from 10:00 - 2:00.

Fire Chief Operations – Chief Dodson stated he has 4 candidates which the department will bring in for testing and interviewing. The gas monitors were ordered and have come in. The check for the Leland boat contract has been received. Cardiac monitors have been ordered. ISO will be re-evaluating the department on Monday. There have been 5 boat calls in the last 2 weeks.
