Emergency Services Advisory Commission Report – Bill Witle – The new Interim Chief was introduced. John Depuy. Rick Royston, retired Fire Chief from Leland Fire Department, will be a consultant to the Township to assist in selecting a new Fire Chief.

The Empire Township Fire Department location – an engineering study was conducted to see the feasibility of upgrading the existing building to meet the requirements. The completed study will be delivered by 1/31/2018 and presented to the Empire Township Board.
