## TOWNSHIP BOARD REPORT:

Peppler reported on the January Township Board meeting:

- Aaron Brown was sworn in as a new Lieutenant in the Glen Lake Fire Department
- A FOIA request was received from the Leelanau Enterprise. A special meeting is being held on Friday, February 2 on this issue and other issues.

Township Attorney Figura commented on the Fire Department issue. He reported that there was some dissention in the Fire Department. The Attorneys and Union rep interviewed 20 people. The decision did not involve any disciplinary action but they agreed on counselling. Amy Hubbel representing the Enterprise filed a FOIA request. It was decided to redact names and some other information that would insure the integrity of the decision they had made. A redacted copy was sent to the Enterprise.
