## **PUBLIC COMMENTS:**

### **BUSINESS:**

  - Peppler moved to close the nominations and Lysaght supported. The motion passed unanimously.
- 2. Pam is continuing work on combining Chapters 1 − 5 using the present Master Plan and the W&W Master Plan. She is aiming at an April date for completion. Chapter 1 is completed.
  - Stege questioned the money spent on revising the W&W Master Plan and not using it. Lance commented on his concern sighting the information obtained from the two Public Hearings as being valuable as well as updated information.
  - A Public Hearing will be held at 7PM immediately prior to the regular Commission meeting on February 4, 2016. The following proposed amendments to the zoning ordinance will be reviewed and then recommended to the Township Board for adoption.
  - a. Definition change of setbacks measure from drip edge
  - b. Definition of campground and recreational unit
  - c. Section VII.1.1 use regulations to include campgrounds
  - d. Definition of site and plot plans
  - e. Procedures for Site Plan Requirements, Review, and Approval
  - f. Definition change of structure add decks and fences
