## ZONING BOARD OF APPEALS REPORT:

Dotterweich commented that there is no activity upcoming.

#### **PUBLIC COMMENTS:**

A resident of Manitou Boulevard had concerns about a home being built on Manitou Blvd and the change in zoning and current setbacks. The Resident has concerns that there are no permits posted or an address posted on the site of the new construction. Cypher had been contacted and the appropriate signage is now on the property. Setbacks were discussed and it was noted that just the three lots down from Coldwell Banker were zoned Commercial.

Roman: The current Zoning Ordinance was reverted back to the way the Ordinance read before the 2007 change as there are several small lots that are unsuitable for a business, with only a single family residence as a practical use.

Some additional comments were made regarding parking along Manitou Boulevard. Roman: You can park within the roadway easement 33 feet from the centerline of the road, most common road easement width is 66 feet.
