**Clerk's Report** – Clerk Laureto reported that the General Fund bills from November 22 through December 19, 2023 totaled \$15,245.44 and the November payroll, which was three pays, totaled \$34,339.30. **Motion B. Hawley, support J. DePuy, to approve the payment of the General Fund bills and payroll. Motion unanimously carried.** 

Emergency Services bills from November 11 through December 12, 2023 totaled \$76,415.44 and the November payroll, which was three pays, totaled \$140,339.51. Motion J DePuy, support D. Lewis, to approve payment of the Emergency Services bills and payroll. Motion unanimously carried.

**Fire Chief Operations Report** – Chief Ferguson reported that there were repairs to 311 which is now back in service. The new engine for the Empire Station will be ready for inspection in early January. It should be in service in Empire in early March. At Empire Township's December Board meeting they approved funding for new entry doors and an exhaust ventilation fan for Station 2. Empire will pay for the cost directly. The Empire Lions Club wants to make a donation to the fire department and they will be purchasing a new refrigerator for Station 2.

- 3. Supervisor Laureto stated that Jeff Gietzen asked to be replaced on the Planning Commission as his final year expires. The Board thanked Jeff for his service and his invaluable expertise for the past three years. Motion T. Laureto, support P. Laureto, to remove, with regret, Jeff Gietzen from the Planning Commission. - 4. Supervisor Laureto presented nominations for various Township Board positions which were voted on by roll call vote as follows:

5. The Board discussed the Resolution and Agreement submitted by the Glen Lake Community Schools to collect school taxes in the summer rather than winter. Motion B. Hawley, support J. DePuy, to authorize the Clerk and the Treasurer to revamp the proposed agreement so that it is in line with current tax collection processes and negotiate the revamped agreement with the school. Motion carried unanimously.

Park and Recreation Board Report: No report.

**Planning Commission Report:** Trustee Hawley reported that the Planning Commission had their public hearing and the revamped Zoning Ordinance has now gone to the County for comment. They will react to the comments and then the Zoning Ordinance will come back to the Township Board for approval.
