### APPROVE AGENDA:

The Agenda was approved as presented.

### MEMBERS CONFLICT OF INTEREST

There were no conflicts by any of the Commission members.

### **APPROVE MINUTES OF PREVIOUS MEETINGS**

Hawley moved to approve the minutes of the March Planning meeting. Thompson supported. The motion carried.

### CORRESPONDENCE

There was no correspondence.

### **TOWNSHIP BOARD REPORT:**

Hawley reported that the Township Board was approving budgets. The Planning Commission budget changed very little except for the legal expenses. The Board approved \$10,000 for that line item.

#### ZONING ADMINISTRATORS REPORT:

Cypher distributed his annual report at the Township Board meeting and his monthly report will be sent to Commission members via email.

Cypher had a request from Sheldon to change from a concrete sidewalk to crushed limestone. There is no jurisdiction from the Road Commission so it is the Township's

decision to approve or deny the request. The Commission members felt the liability and consistency with the rest of the sidewalks has to be considered.

Cypher commented that Glen Arbor does not have a sidewalk ordinance. Commission discussed.

Hawley initiated a motion to deny the Sheldon request to change the sidewalk from concrete to crushed gravel. Dotterweich supported. Motion carried.

# ZONING BOARD OF APPEALS REPORT:

Cypher reported that the Township Board is going get a letter from our legal counsel giving the updated status of the Connel property.

Commission discussed.

Dotterweich reported that there has been no activity with the ZBA.

Roman stated that there are not a lot of updates since the township almost 80% National Park and fairly well built out. Roman injected that demographics is a good place to start.

Dotterweich reminded that there are approved minutes from the Board about the changes the Commission made to the plan for single family in the Business District. That change will be adopted going forward.

Dotterweich gave a report on his participation on the Board of Review which prompted Commission discussion

Hawley cleaned up and simplified the Ordinance Text and provided printed copies. The Commission discussed and approved for general consensus to be included in the next Ordinance revision.
