Hawley reported:

- The Township Board has completed phase 3 of the firehouse project, including evaluation of Fire House remodel for women's washrooms and sleeping quarters.
- A box will be installed for Narcan behind the Town hall.
- Community members would like to see the speed limit change on 675 from 55 to 45. While the Township now has speed limit input, it rejected the request as the Road Commission's study showed an average speed of 48 mph.
- The Township Board is getting bids on getting the parking lot repaved.

# ZONING ADMINISTRATORS REPORT:

Cypher reported on The Fisher Store project: The Ames project doesn't have the Road Commission permit and also needs a survey to relocate the well. There may be a problem with no extra parking. Ames spoke of a property line adjustment. It was pointed out that the adjustment would split the parcel across zoning districts. The

Health Dept. approved a small site. The proposed drain field was moved on to the property owner's second lot. MDOT approved the location for the parking but it cannot enlarge the parking lot.
