- 2. Payment of Final GLFD bills for FY 24-25. P. Laureto presented the bills from March 12 March 29, 2025 which totaled \$49,972.24. Motion B. Hawley, support D. Lewis, to approve payment of the Fire Department bills as presented. Motion carried unanimously.
- 3. Clerk Laureto reviewed Resolution #8-2025 to use the uncommitted General Fund funds to repave the Township Hall Parking Lot. Motion D. Lewis, support B. Hawley, to approve Resolution #8-2025 as presented. Roll call vote. Voting Aye: B. Hawley, D. Lewis, P. Laureto and T. Laureto; Nay: none; Absent: J. DePuy. The Supervisor declared the motion passed.
- 4. Clerk Laureto reviewed Resolution #9-2025, FY 2024-2025 Budget Amendments #2 highlighting which line items needed to be increased or decreased. Motion D. Lewis, support B. - 5. Chief Ferguson reviewed GLFD FY 2024-2025 Budget Amendments dated 3/31/2025 highlighting which line items need to be increased or decreased. Motion D. Lewis, support B. - 6. Resolution #10-2025 the Township General Appropriations Act was presented by Supervisor Laureto. Each year the Act notes the estimated revenues, which are \$675,050.00, the millage levied which is .4514 mills, and the estimated expenditures which are \$705,084.00. Of that, \$605,084.00 will come from committed General Fund funds and \$100,000.00 will come from uncommitted General Fund funds per resolution #8-2025. Motion B. Hawley, support D. Lewis, to adopt Resolution #10-2025 the Township's General Appropriations Act. Roll Call vote. Voting Aye: B. Hawley, D. Lewis, P. Laureto and T. Laureto; Nay: none; Absent: J. DePuy. The Supervisor declared the motion passed.
- 7. Clerk Laureto stated that a Public Budget Hearing was held on March 18, 2025 and there were four changes to the proposed FY 2024-2025 budget since then; the tax collection and admin fee amounts were corrected, \$4000 was moved from Park non-capital account to capital account and \$100.00 was added to the snowplowing account number. Motion B. Hawley, support D. Lewis, to approve the proposed budget for FY 2024-2025 by cost center. Roll Call vote. Voting Aye: B. Hawley, D. Lewis, P. Laureto and T. Laureto; Nay: none; Absent: J. DePuy. The Supervisor declared the motion passed.
