#### a. Holmatro Rescue Tools

We purchased new battery-operated tools, the Jaws of Life. The old rescue tools have been unused and sitting on floor taking up space. They are not serviceable but have life left in them and we would like to donate them. DePuy asked how we would advertise and Dykgraaf said word of mouth. DePuy made a motion to donate them to another fire station. Church seconded. All in favor.

#### b. FY 20 Budget Amendments

Dykgraaf reviewed the proposed budget amendments saying that the ladder truck purchase, cost for converting 352 to 381, and the first payment on the new ambulance are being added to the FY25 budget. P. Laureto said a recommendation to the Township Board is needed. Godbout asked if we have identified any offsets. P. Laureto said that the fund balance will be used as the offset and that Glen Arbor will be paying for the ladder truck. The proceeds from whatever vehicles are sold after the new trucks are received will go to replenish the fund balance. Church motioned to recommend to the Glen Arbor Township Board that they approve the proposed budget amendments. DePuy seconded. All in favor.

## c. Draft / Proposed FY 27 Budget

P. Laureto relayed that Ferguson said there will likely be some changes made to the proposed budget, so all are welcome to look and communicate in the next month if it looks like we need adjustments. DePuy said Blue Cross / Blue Shield insurance has gone up a lot and wondered if insurance increases are planned for in the proposed budget. There was a 14% increase this year, so we have planned for that next year. Last year there was a 13% increase. P. Laureto said that the next ESAC meeting is September 10 and Public Budget meeting is that evening. All are encouraged to come.

#### XIII. Board Member Comments

DePuy related that Kasson Township is in the process of finalizing their new fire station on M72. There is an Open House hearing and all are encouraged to attended.
