Clerk's Report – The General Fund bills from October 22, 2025 through November 14, 2025 totaled \$14,725.80 and the October payroll, was \$27,099.16. Motion T. Laureto, support D. Lewis, to approve payment of the General Fund bills and payroll. Motion carried unanimously.

Emergency Services bills from October 15, 2025 through November 11, 2025 totaled \$43,471.78 The October payroll was \$170,563.69. Motion T. Laureto, support D. Lewis, to approve the payment of the Emergency Services bills and payroll. Motion carried unanimously.

Fire Chief Operations Report Capt. Dykgraaf reported that the department had 49 calls in October. Paramedic Ruth celebrated his 4-year anniversary. GLFD was able to tour the new Cherry Republic warehouse. The department also attended the Glen Lake School Fall Festival and hosted the Glen Arbor Women's Club for a short presentation, tour of the building and apparatus. They performed recovery training in the bay before the ramp was pulled for the season. Engine 311's power steering was replaced. The 9/11 memorial has been winterized. The new scheduling software which the department had demoed is now in use. The Empire Open House was held.
